Personality and Communication Skills – 50% Each delegate will be evaluated by a panel of judges on her ability to communicate, showcase her personality, express herself, and highlight her achievements, all while displaying grace and beauty.

Fitness and Health - 25%

Delegates will compete in a swimsuit provided by the pageant, where judges will assess overall fitness, health, and confidence on stage. Poise in Evening Gown – 25%

Delegates will be judged on elegance, poise, and stage presence while wearing an evening gown of their choice, allowing them to express their personal style and sophistication.
